Description

The University of Luxembourg Summer Legal Clinic is based on the teaching concept and experiential learning approach of the Uni.lu Consumer Law Clinic. Students will work on case studies, conduct mock interviews with clients, as well as learning about client interaction, the appropriate use of legal jargon and developing and applying solutions to real-life scenarios in the field of consumer law.

The Summer Legal Clinic will be hosted in English. The programme is organised in close cooperation with the Luxembourg Bar Association, allowing students to get first-hand insights from lawyers and clinic coaches.

Outside of Clinic hours, students will have time to discover the rich history, cultural heritage and beautiful setting of Luxembourg City.

About STARS

Skills Transfer in Academia, a Renewed Strategy (STARS) is a project founded under the Erasmus+ programme. It brings together the University of Luxembourg (coordinator), Università degli Studi di Brescia and Università degli Studi Roma Tre (Italy), Palacký University Olomouc (Czech Republic), and the Romanian-American University Bucharest (Romania).
